## Purpose and legal basis of the processing of personal data

The security camera system with recording is used for the purpose of protecting the health and safety of persons, protecting the property of the Controller or property under the Controller's management, preventing and detecting criminal and other unlawful activities. CCTV recordings may be used for the purpose of evidence in criminal proceedings, proceedings for offences or in the recovery of claims for damages. The legal basis for the processing of personal data is the legitimate interest of the Data Controller within the meaning of Article 6(1)(f) of the GDPR. The legitimate interest of the Data Controller is the protection of the health and property of the Data Controller, the prevention and detection of criminal and other unlawful activities.

# Categories and source of personal data

Image recordings and manifestations of a personal nature of persons present in the monitored premises. Personal data is collected by means of monitoring cameras.

#### **Monitored areas**

The Operator's exterior and interior premises are monitored by a security camera system. Each monitored area is duly marked with a pictogram and basic information in accordance with the GDPR and related regulations.



# **Category of recipients**

The personal data of the data subjects are processed by the authorised employees and contractual partner in the field of security services, IBS - SECURITY, s.r.o., Banská 6301, 915 01 Nové Mesto nad Váhom, ID No.: 45404828. In justified cases, the data may be disclosed to law enforcement authorities, competent courts or other state administration authorities.

## Transfer of personal data to third countries and analytics

Personal data is not transferred to third countries and personal data is not subject to automated individual decision-making or profiling.

# Retention period of personal data

The controller shall retain the processing of personal data for a period of 7 days, unless the recording is used for the purposes of criminal or similar proceedings.

# Rights of the data subject

### THE RIGHT TO OBJECT TO THE PROCESSING OF PERSONAL DATA

You may object at any time to the processing of your personal data based on our legitimate interests. We must properly assess the objection. Unless we can demonstrate that we have compelling legitimate grounds for the processing and that these override your interests, rights and freedoms, we will no longer process your personal data.
